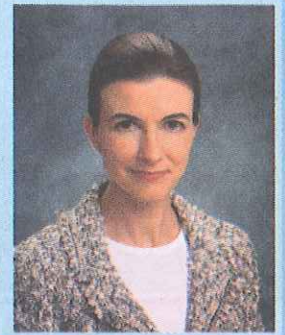

Ms. Spadafor assumed her role as the Chief Executive Officer at Saint Jude's Ranch for Children in 2006 when the local non-profit was on the brink of closing its doors. She designed and led a financial turnaround of the Ranch, which is now debt free and possess a strong balance sheet. Saint Jude's Ranch for Children was able to launch five new programs within the last two years, serving more children and families who desperately need their services.
